David Glenn commented that it could be argued that the \$20k loss could be reduced to approx. \$10k if you take into account the stored provisions currently in the lodge plus the scaffolding asset.

Subscriptions and fees for 2024:

- Annual sub for Senior members: (currently \$190) propose an increase to \$200
- Annual sub for Tertiary members: (currently \$190) propose an increase to \$200
- Annual sub for Veteran members: (currently \$95) propose an increase to \$100
- Annual sub for Junior members: (currently \$50) propose an increase to \$55
- Annual sub for Associate members: (currently \$35 Senior associates only) propose an increase to \$40
- Work party levy: (currently \$190 applies to senior and life-subscription members if the member does not attend a work party or equivalent committee-approved event) propose an increase to \$200
- Committee is given the discretion to set or waive joining fee, and set or waive early payment discount for subs or apply a late payment levy
