• Bookings Officer: Jenny Muir – Steve drew special attention to the work Jenny does throughout the year, particularly this year given the introduction of the new booking system and the disruption that Covid had on lodge bookings – this meant a great deal of extra work for Jenny.

General Business:

Brian gave an overview of the proposed changes and explained these were mainly to bring the rules in line with current practises. The new Tertiary membership is to encourage and assist Juniors to stay on as club members once they move into Tertiary education.

- COVID-19 Protection Framework RMCA is looking into this and will advise clubs in due course. There will
 be more discussion at the 2022 Planning Meeting but we recognise that there may not be clear guidelines by
 then, and that this can be a rapidly changing space.
- **Travel restrictions** the club will be offering some form of relief to members who were affected by this year's Covid travel restrictions. This will be finalised at 2022 Planning Meeting and communicated to members early in the year.
- RAL Shareholders meeting to be held Friday 27 November. David Glenn gave an overview of the issues: RAL are in a perilous financial position and are trying to attract external capital into the business. There is a proposal to change the company constitution to create a new entity in an effort to hive down assets so the business appears more attractive to potential investors. While not necessarily an unreasonable step to take, there is a real risk that effective control of RAL could change radically, and there may be adverse effects for Life Pass Holders. RAL have not been transparent in communication, information on how the new company will be set up etc. More information is urgently required. The meeting has been changed at late notice from a voting to an information only meeting. Given the structure of RAL and the very limited voting power clubs and individual shareholders have, the most effective way of making our voice heard is through the RAL Trust, who are a 45% shareholder of RAL.
